TERMS OF MEMBERSHIP

PARTIES

1. Daresbury Health & Fitness Club shall be operated as a propriety club owned by Daresbury Laboratory and located at Daresbury Science and Innovation centre, Keckwick Lane, Warrington, Cheshire, WA4 4AD. The club will be administered by 3d Leisure or by another nominated person. The owner shall solely determine the facilities of the club; any amendment or replacement shall be at the owner's discretion. The membership agreement (in which are incorporated these terms and conditions) is made between 3d Leisure Ltd in conjunction with 3dfitness and the individual applicants named overleaf.

ACCESS

- 1. Members must present their site pass card to the reader on the gym doors to gain access to the gym each time they visit the club. The club reserves the right to refuse entry without presentation of these items.
- 2. If for any reason you do not have your site pass then a visitor pass can be signed out at security reception
- 3. Entry will be refused to anybody under the influence of drugs or alcohol.
- 4. Appropriate clothing and footwear must be worn in the club. In the gymnasium area outdoor shoes must not be worn. No animals are permitted in the club, other than guide dogs
- 5. The club will open from 05:00 22:00 7 days of the week. The fitness club will be closed on Bank Holiday Mondays and for Easter Bank Holiday weekend and the Christmas break. Last entry is 30 Minutes before closing.
- 6. The club reserves the right to close facilities without prior notice should the need arise. Whenever possible advanced warning will be given.
- 7. The club reserves the right to terminate membership without giving reason. (Refunds may be available subject to circumstances of membership termination)

HEALTH & SAFETY

- 1. Prior to using the gymnasium, a Personal Health Statement must be read and signed and a gym induction completed.
- 2. You must abide by the 'buddy system' in which members must use the facility in pairs when the facility is unstaffed to ensure members safety or use the lone worker alarms provided on the gym desk and notify security on ext.3277 if using the facility alone.
- 3. Food is not permitted in the gym or in the changing rooms.
- 4. Smoking is not permitted anywhere in the club.
- 5. Please wipe down equipment and replace weights after use.

ADMINISTRATION

- 1. The club management reserves the right to reject any application for membership without giving a reason.
- 2. The club fees and tariffs shall be determined by the club and may be altered at any time. Members will be notified in advance of any changes
- 3. The club reserves the right to terminate the membership of any member without notice in the event of a member committing a serious breach of the clubs terms of membership.
- 4. On cancellation or termination of membership, no refund will be made.
- 5. All members who wish to cancel their membership must do so in writing giving 28 days notice.
- 6. Site pass cards are only for use by the member and are not transferable under any circumstances.

OTHER TERMS

- 1. CCTV is installed and is monitored by security for member's safety.
- 2. Lockers should only be used for storage of personal belongings.
- 3. Property is stored at the owner's risk and the club will accept no liability for loss or damage.
- 4. Lockers will be cleared every 24 hours and all items removed.
- 5. The club reserves the right to dispose of any items not claimed within 4 weeks.
- 6. The club reserves the right to amend these terms at its absolute discretion. Notification of changes will be displayed on the notice board.

MEMBERSHIP

- 1. Membership is only available for Daresbury Laboratory employees, contactors and tenants and employees of Vanguard House and Techspace one and two.
- 2. All members will pay a subscription beginning when the member is accepted for membership and shall be payable by monthly payments in which case it will be debited from the members bank account by monthly direct debit
- 3. Members have the ability to cancel their membership in accordance with the cancellation clauses set out in these Terms and Conditions, this is with 30 days notice after the initial 6 monthly contract period has concluded. Please note that the continuance of monthly payments to 3d Leisure will constitute the renewal of the membership at the prevailing rate in accordance with these Terms and Conditions.
- 4. All memberships are subject to an initial 6 month contract, all memberships will then continue rolling month by month unless cancelled in writing to the gym manager
